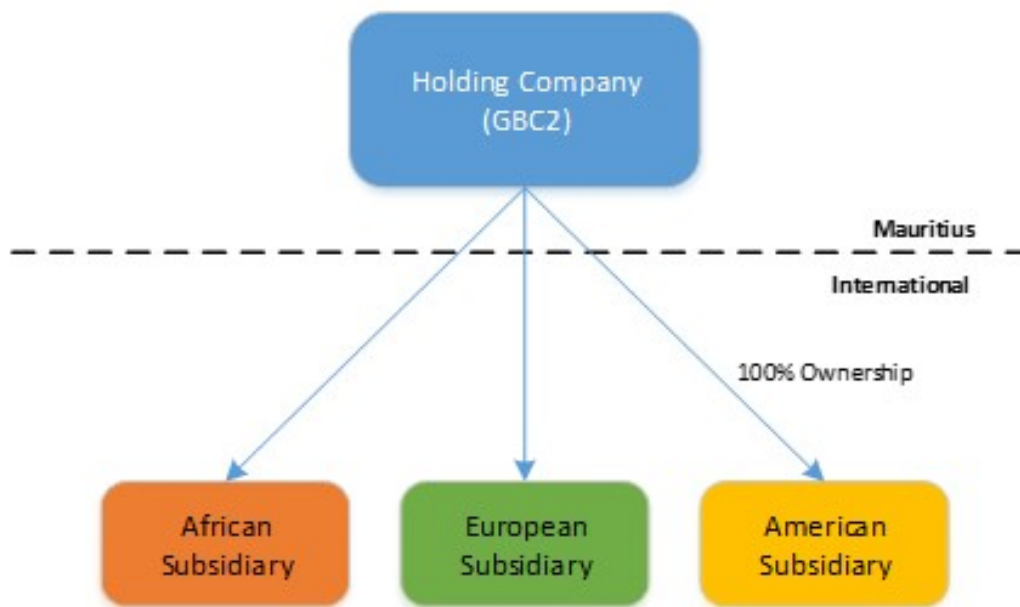




GLOBAL BUSINESS LICENSE CATEGORY 2

A Category 2 Global Business License Company

A Category 2 Global Business License company is a Mauritian resident corporation which proposes to conduct business outside Mauritius. The company may apply to the Financial Services Commission for a Category 2 Global Business License (“GBL2”).

A GBL2 provides for greater flexibility and it is a suitable vehicle for holding and managing private assets. However it is not allowed to raise capital from the public or to conduct any financial services or to act as a fiduciary.

- Rendering accounting services.
- Back office administration including issuing invoices, cash collection and the making payments on behalf of the Company with respect to day-to-day business.
- Reviewing agreements to be signed by the Board on behalf of the Company.

Key Features

- May conduct any legal Global business activity. However, the company cannot undertake activities such as banking services, financial services, acting as corporate trustee.
- Standard licensing conditions.
- Dealings with residents is not permissible
- Incorporator company allowed.
- Submission of un-audited financial summary in prescribed form required within 6 months of financial year end.
- Not a taxable entity in Mauritius and as such cannot qualify for Tax Residence Certificate issued pursuant to Double Tax Avoidance Agreements to which Mauritius is party.
- Mauritian resident may not hold beneficial interest.
- Registered office must be in Mauritius
- May not hold immovable property in Mauritius.
- Must be administered by a Management Company directly.
- Professional expatriate staff can be employed and can obtain Occupation permits to live and work in Mauritius.
- Can have a corporate director.
